Whatever your reason, when you need to replenish your stocks, simply use the credit that you have accumulated on your share.

## **Saving couldn't be easier**

You can start a standing order by completing and returning the attached form to The Society. We will send a copy to your bank and, thereafter, your bank will automatically transfer the prescribed amount to your Wine Society share each month on a date specified by you.

Once the standing order has been set up, you may place orders at any time. If you wish to order wines of a higher value, you can pay for the excess by debit/credit card or cheque in The Society's Cellar Showroom at Stevenage or through Member Services or by visiting the website at **[www.thewinesociety.com/myaccount](http://www.thewinesociety.com/myaccount)** Cash is also accepted in the showroom.

Please note accumulated credit cannot be used for wines purchased from our showroom in France.
